RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT- SMALL VALUE PROCUREMENT AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE SUPPLY AND DELIVERY OF CONSTRUCTION MATERIALS AND SUPPLIES FOR THE IMPROVEMENT OF PARKS AND MONUMENTS UNDER POW M 2025-05-046 DATED MAY 29, 2025

WHEREAS, per Purchase Request No. 2025-06-175 dated June 16, 2025, the Municipality of Socorro has to purchase construction materials and supplies for the Improvement of Parks and Monuments under POW M 2025-05-046 dated May 29, 2025 with an Approved Budget for the Contract of Eighty Five Thousand Eight Hundred Thirty Six Pesos (Php.85,836.00);

WHEREAS, as a general rule, all procurement shall be done thru competitive public bidding except whenever justified by the conditions in order to promote economy and efficiency , may resort to any of the alternative mode of procurement;

WHEREAS, the above-mentioned procurement is recommended for Negotiated Procurement under Small Value Procurement considering that such procurement does not exceed the threshold of Two Hundred Thousand (P200,000.00) as prescribed in Annex H of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, under Section 53.9 of RA 9184, Small Value Procurement is one of cases that calls for the use of Negotiated Procurement;

NOW THEREFORE, we the members of the Bids and Awards Committee do hereby RESOLVED as it is hereby HEREBY RESOLVED -

- To recommend that the supply and delivery of construction materials and supplies for the Improvement of Parks and Monuments under POW M 2025-05-046 dated May 29, 2025 with an Approved Budget for the Contract of Eighty Five Thousand Eight Hundred Thirty Six Pesos (Php.85,836.00) be procured through alternative mode of procurement – Negotiated Procurement under Small Value Procurement;
