**RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT- SMALL VALUE PROCUREMENT AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE PURCHASE OF CONSTRUCTION MATERIALS AND SUPPLIES FOR THE FABRICATION AND INSTALLATION OF PLAYGROUND EQUIPMENT (SLIDE) AT LAPOG ELEMENTARY SCHOOL UNDER POW M 2025-05-047 DATED MAY 29, 2025**

WHEREAS, per Purchase Request No. 2025-06-186 dated June 16, 2025, the Municipality of Socorro has to purchase construction materials and supplies for the Fabrication and installation of playground equipment (slide) at Lapog Elementary School under POW M 2025-05-047 dated May 29, 2025 with an Approved Budget for the Contract of Seventy Six Thousand Nine Hundred Twenty Six Pesos (Php.76,926.00);

WHEREAS, as a general rule, all procurement shall be done thru competitive public bidding except whenever justified by the conditions in order to promote economy and efficiency, may resort to any of the alternative mode of procurement;

WHEREAS, the above-mentioned procurement is recommended for Negotiated Procurement under Small Value Procurement considering that such procurement does not exceed the threshold of Two Hundred Thousand (P200,000.00) as prescribed in Annex H of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, under Section 53.9 of RA 9184, Small Value Procurement is one of cases that calls for the use of Negotiated Procurement;

NOW THEREFORE, we the members of the Bids and Awards Committee do hereby RESOLVED as it is hereby HEREBY RESOLVED -

- 1) To recommend that the purchase of construction materials and supplies for the Fabrication and installation of playground equipment (slide) at Lapog Elementary School under POW M 2025-05-047 dated May 29, 2025 with an Approved Budget for the Contract of Seventy Six Thousand Nine Hundred Twenty Six Pesos (Php.76,926.00) be procured through alternative mode of procurement – Negotiated Procurement under Small Value Procurement;
- 2) To recommend for approval of the Municipal Mayor the foregoing findings.
