- WHEREAS, the Municipality of Socorro through its Bids and Awards Committee, advertised and posted the Invitation to Bid for the Supply and Delivery of Construction Materials and Supplies for the Construction/Improvement of Legislative Building in the PhilGEPS website, LGU website and at the conspicuous places in the premise of the Municipality of Socorro on June 4-16,2025;
- WHEREAS, in response thereto, one (1) prospective bidder was able to purchase bidding documents on June 13,2025 and submit its respective bid before the set deadline on June 16,2025;
