RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT- SMALL VALUE PROCUREMENT AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE INSTALLATION OF TENT, DECORATION & ROOFING AND PROVISION OF TABLES AND CHAIRS FOR VIEWING PUBLIC DURING THE HOLDING OF PAKAPYA AGTIKE FESTIVAL IN-PLACE PRESENTATION IN LINE WITH THE CELEBRATION OF 62ND FOUNDING ANNIVERSARY OF THE MUNICIPALITY OF SOCORRO

WHEREAS, per Purchase Request No. 2025-06-183 dated June 16, 2025, the Municipality of Socorro has to cause the installation of tent, decoration & roofing and provision of tables and chairs for viewing public during the holding of Pakapya Agtike Festival In-Place Presentation in line with the celebration of 62nd Founding Anniversary of the Municipality of Socorro with an Approved Budget for the Contract of Eighty Thousand Pesos (Php.80,000.00);

WHEREAS, as a general rule, all procurement shall be done thru competitive public bidding except whenever justified by the conditions in order to promote economy and efficiency, may resort to any of the alternative mode of procurement;

WHEREAS, the above-mentioned procurement is recommended for Negotiated Procurement under Small Value Procurement considering that such procurement does not exceed the threshold of Two Hundred Thousand (P200,000.00) as prescribed in Annex H of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, under Section 53.9 of RA 9184, Small Value Procurement is one of cases that calls for the use of Negotiated Procurement;

NOW THEREFORE, we the members of the Bids and Awards Committee do hereby RESOLVED as it is hereby HEREBY RESOLVED -

- To recommend that the installation of tent, decoration & roofing and provision of tables and chairs for viewing public during the holding of Pakapya Agtike Festival In-Place Presentation in line with the celebration of 62nd Founding Anniversary of the Municipality of Socorro with an Approved Budget for the Contract of Eighty Thousand Pesos (Php.80,000.00) be procured through alternative mode of procurement Negotiated Procurement under Small Value Procurement;
