#### BAC RESOLUTION NO. 2025-06-178 RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING ISSUANCE OF NOTICE OF AWARD

- WHEREAS, the Municipality of Socorro through its Bids and Awards Committee, advertised and posted the Invitation to Bid for the Supply and Delivery of Carabao (Bubaline) and Cattle (Bovine) in the PhilGEPS website and at the conspicuous places in the premise of the Municipality of Socorro on June 4, 2025 to June 16, 2025;
- WHEREAS, in response thereto, ERQ Livestock Trading from Maligaya, Gloria, Oriental Mindoro was the sole bidder who purchased bidding documents on June 11, 2025 and submitted its bid before the set deadline on June 16, 2025;
- WHEREAS, during the preliminary evaluation of bids, the technical and financial proposal of ERQ Livestock Trading was found to be substantially complying;
- WHEREAS, upon post-qualification or careful examination, validation and verification of all eligibility, technical and financial requirements submitted by the bidder with the Single Calculated Bid, the bid of ERQ Livestock Trading was found to be responsive;
- NOW THEREFORE, we, the members of the Bids and Awards Committee do hereby RESOLVE as its is hereby RESOLVED to declare the bid of ERQ Livestock Trading with a calculated financial proposal of Four Hundred Ninety Nine Thousand Pesos (P 499,000.00) as the Single Calculated and Responsive Bid;

Perez, M.D. as the Head of Procuring Entity (HOPE) that the contract for the Supply and Delivery of Carabao (Bubaline) and Cattle (Bovine) be awarded to ERQ Livestock Trading and that the Notice of Award (NOA) be issued for this undertaking pursuant to Section 37 of the 2016 Revised Implementing Rules and Regulations of RA 9184.
