WHEREAS, the Municipality of Socorro through its Bids and Awards Committee, advertised and posted the Invitation to Bid for the Improvement of Socorro Public Market Buildings -Painting Works in the PhilGEPS website, LGU website and at the conspicuous places in the premise of the Municipality of Socorro on May 27,2025 to June 25,2025 under IB No. 2025-05-019;

WHEREAS, in response to said advertisement, Relict Construction Inc. and RJJJ Engineering Services who both purchased bidding documents on June 11,2025 and June 20,2025,respectively and Relict Construction Inc. submitted its bid on June 25,2025 while RJJJ Engineering Services failure to submit its bid;

WHEREAS, during the preliminary evaluation of bids, the technical and financial proposal of Relict Construction Inc. were both found to be substantially complying;

WHEREAS, upon post-qualification or careful examination, validation and verification of all eligibility, technical and financial requirements submitted by the bidder with the Single Calculated Bid, the bid of Relict Construction Inc. was found to be responsive;


NOW THEREFORE, we, the members of the Bids and Awards Committee do hereby RESOLVE as its is hereby RESOLVED to declare the bid of Relict Construction Inc. with a calculated financial proposal of Three Million One Hundred Forty Six Thousand Eight Hundred Forty Pesos and Fifty One Centavos (P 3,146,840.51) as the Single Calculated and Responsive Bid;
