RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING ISSUANCE OF NOTICE OF AWARD

WHEREAS, the Municipality of Socorro through its Bids and Awards Committee, advertised and posted the Invitation to Bid for the Construction of Flood Control Structure at Barangay Calubayan in the PhilGEPS website, LGU website and at the conspicuous places in the premise of the Municipality of Socorro on June 10, 2025- June 30, 2025 under IB No. 2025-06-024;

WHEREAS, in response to said advertisement, RJJJ Engineering Services and JSLBuilders and Construction Supply who both purchased bidding documents on June 11, 2025 and June 20, 2025, respectively and RJJJ Engineering Services submitted its bid on June 30, 2025 while JSLBuilders and Construction Supply failure to submit its bid;

WHEREAS, during the preliminary evaluation of bids, the technical and financial proposal of RJJJ Engineering Services were both found to be substantially complying;

WHEREAS, upon post-qualification or careful examination, validation and verification of all eligibility, technical and financial requirements submitted by the bidder with the Single Calculated Bid, the bid of RJJJ Engineering was found to be responsive;


NOW THEREFORE, we, the members of the Bids and Awards Committee do hereby RESOLVE as its is hereby RESOLVED to declare the bid of RJJJ Engineering Services with a calculated financial proposal of Two Million One Hundred Fifty Nine Thousand One Hundred Seventeen Pesos and Thirty Seven Centavos (P 2,159,117.37) as the Single Calculated and Responsive Bid;

RESOLVED FURTHER to respectfully recommend to Hon. Nemmen O. Perez, M.D. as the Head of Procuring Entity (HOPE) that the contract for the Construction of Flood Control Structure at Barangay Calubayan to be awarded to RJJJ Engineering Services and that the Notice of Award (NOA) be issued for this undertaking pursuant to Section 37 of the 2016 Revised Implementing Rules and Regulations of RA 9184.
