CONTRACT AGREEMENT

THIS AGREEMENT made the 6th day of January 2025 between Municipality of Socorro with the office address at Municipal Compound E.D. WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Supply and Delivery of Brand New Water Truck and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Three Million One Hundred Fifty Thousand Pesos (Php 3,150,000.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are 1. respectively assigned to them in the Conditions of Contract referred to.

 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- Performance Security; iii.
- Notice of Award of Contract; and the Bidder's conforme thereto; and iv.
- Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of Three Million One Hundred Fifty Thousand Pesos (Php 3,150,000.00) or such other sums as may be ascertained, QSJ MOTORS PHILS INC. agrees to Supply and Delivery of Brand New Water Truck in accordance with his/her/its Bid.
- The Municipality of Socorro agrees to pay the above-mentioned sum in 4. accordance with the terms of the Bidding.
