RESOLUTION NO. 2023-11-522

RESOLUTION RECOMMENDING THE USE OF SHOPPING- AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE PURCHASE OF SUPPLIES AND MATERIALS TO BE USED IN THE CONDUCT OF STANDARD FIRST AID TRAINING AND BASIC LIFE SUPPORT TRAINING (SFAT/BLS) ON DECEMBER 5-6, 2023.

WHEREAS, per Purchase Request No. 2023-11-532 dated November 20, 2023 the Municipality of Socorro has to purchase of supplies and materials to be used in the conduct of Standard First Aid Training and Basic Life Support Training (SFAT / BLS) on December 5-6, 2023 with an Approved Budget for the Contract Amount of Sixty Three Thousand Four Hundred Forty Seven Pesos (Php 63,447.00);

WHEREAS, under Republic Act No. 9184 (RA 9184), otherwise known as "Government Procurement Reform Act" (GPRA), and its Revised Implementing Rules and Regulations (RIRR), all procurement shall be undertaken through competitive public bidding except only under highly exceptional cases where the procuring entity may resort to alternative methods of procurement; and the same shall be subject to the prior approval of the Head of the Procuring Entity.

WHEREAS, Under Section 52 of the 2016 Revised IRR of RA 9184, Shopping is a method of procurement of goods whereby the procuring entity simply request for the submission of price quotation readily available off-the shelf goods or ordinary/regular equipment to be procured directly from supplier of known qualifications;

WHEREAS, pursuant to the above-mentioned provision, shopping may be employed the for the procurement of ordinary or regular; office supplier and equipment not available in the Procurement Service involving an amount not exceeding the threshold prescribed in annex H of said IRR;

NOW THEREFORE, we the members of the Bids and Awards Committee do hereby RESOLVED as it is HEREBY RESOLVED

- To recommend that the supplies and materials to be used in the conduct of Standard First Aid Training and Basic Support Training (SFAT / BLS) on December 5-6, 2023 with an Approved Budget for the Contract Amount of Sixty Three Thousand Four Hundred Forty Seven Pesos (Php 63,447.00) be procured through shopping;
