RESOLUTION NO. 2023-12-591

RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT- SMALL VALUE PROCUREMENT AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE PURCHASE OF FOOD STUFF AND OTHER SUPPLIES TO BE USED IN THE PREPARATION OF MEALS AND SNACKS FOR THE ATTENDEES OF ELDERLY YEAR-END PROGRAM EVALUATION AND ASSEMBLY 2023

WHEREAS, per Purchase Request No. 2023-12-565 dated December 1, 2023, the Municipality of Socorro has to purchase food stuff and other supplies to be used in the preparation of meals and snacks for the attendees of Elderly Year-End Program Evaluation and Assembly 2023 with an Approved Budget for the Contract of Seventy Nine Thousand Three Hundred Forty Seven Pesos (Php 79,347.00);

WHEREAS, under Republic Act No. 9184 (RA 9184), otherwise known as "Government Procurement Reform Act" (GPRA), and its Revised Implementing Rules and Regulations (RIRR), all procurement shall be undertaken through competitive public bidding except only under highly exceptional cases where the procuring entity may resort to alternative methods of procurement; and the same shall be subject to the prior approval of the Head of the Procuring Entity.

WHEREAS, the above mentioned procurement is recommended for Negotiated Procurement under Small Value Procurement considering that such procurement does not exceed the threshold of Two Hundred Thousand (P200,000.00) as prescribed in Annex H of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, under Section 53.9 of 2016 Revised IRR of RA 9184, Small Value Procurement is one of cases that calls for the use of Negotiated Procurement;

NOW THEREFORE, we the members of the Bids and Awards Committee do hereby RESOLVED as it is HEREBY RESOLVED

- 1) To recommend that food stuff and other supplies to be used in the preparation of meals and snacks for the attendees of Elderly Year-End Program Evaluation and Assembly 2023 with an Approved Budget for the Contract of Sixty Three Thousand Eight Hundred Pesos Only (Php 79,347.00) be procured through alternative mode of procurement Negotiated Procurement under Small Value Procurement;
- 2) To recommend for approval of the Municipal Mayor the foregoing findings.
