RESOLUTION NO. 2023-12-594

RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT- SMALL VALUE PROCUREMENT AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE PURCHASE OF MEALS AND SNACKS FOR THE ATTENDEES OF ORIENTATION ON COMPREHENSIVE DANGEROUS DRUG ACT OF 2002 OR REPUBLIC ACT 2165 FOR THE SANGGUNIAN KABATAAN AND THE KATIPUNAN NG MGA KABATAAN.

WHEREAS, per Purchase Request No. 2023-12-571 dated December 1, 2023, the Municipality of Socorro has to purchase meals and snacks for attendees of orientation on Comprehensive Dangerous Drug Act of 2002 or Republic Act 2165 for the Sangguniang Kabataan and the Katipunan ng Kabataan with an Approved Budget for the Contract of Fifty Nine Thousand Four Hundred Pesos (Php 59,400.00);

WHEREAS, under Republic Act No. 9184 (RA 9184), otherwise known as “Government Procurement Reform Act” (GPRA), and its Revised Implementing Rules and Regulations (RIRR), all procurement shall be undertaken through competitive public bidding except only under highly exceptional cases where the procuring entity may resort to alternative methods of procurement; and the same shall be subject to the prior approval of the Head of the Procuring Entity.

WHEREAS, the above mentioned procurement is recommended for Negotiated Procurement under Small Value Procurement considering that such procurement does not exceed the threshold of Two Hundred Thousand (P200,000.00) as prescribed in Annex H of 2016 Revised Implementing Rules and Regulations of RA 9184;


WHEREAS, under Section 53.9 of 2016 Revised IRR of RA 9184, Small Value Procurement is one of cases that calls for the use of Negotiated Procurement;

NOW THEREFORE, we the members of the Bids and Awards Committee do hereby **RESOLVED** as it is **HEREBY RESOLVED**

- 1) To recommend that meals and snacks for attendees of orientation on Comprehensive Dangerous Drug Act of 2002 or Republic Act 2165 for the Sangguniang Kabataan and the Katipunan ng mga Kabataan with an Approved Budget for the Contract of Fifty Nine Thousand Four Hundred Pesos (Php 59,400.00) be procured through alternative mode of procurement – Negotiated Procurement under Small Value Procurement;
- 2) To recommend for approval of the Municipal Mayor the foregoing findings.
