RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT- SMALL VALUE PROCUREMENT AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE SUPPLY AND DELIVERY OF MATERIALS AND SUPPLIES AND REPAIR SERVICES FOR THE REPAIR AND MAINTENANCE OF CLOSED CIRCUIT TELEVISION (CCTV)

WHEREAS, per Purchase Request No. 2024-08-314 dated August 8, 2024, the Municipality of Socorro has to purchase materials and supplies and repair services for the repair and maintenance of Closed Circuit Television (CCTV) with an Approved Budget for the Contract of One Hundred Ninety One Thousand Eight Hundred Pesos (Php.191,800.00);

WHEREAS, as a general rule, all procurement shall be done thru competitive public bidding except whenever justified by the conditions in order to promote economy and efficiency, may resort to any of the alternative mode of procurement;

WHEREAS, the above-mentioned procurement is recommended for Negotiated Procurement under Small Value Procurement considering that such procurement does not exceed the threshold of Two Hundred Thousand (P200,000.00) as prescribed in Annex H of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, under Section 53.9 of of RA 9184, Small Value Procurement is one of cases that calls for the use of Negotiated Procurement;
