WHEREAS, the Municipality of Socorro through its Bids and Awards Committee, advertised and posted the Invitation to Bid for the Construction/Establishment of Potable Water System at Barangay Subaan in the PhilGEPS website, LGU website and at the conspicuous places in the premise of the Municipality of Socorro on August 7, 2024 to August 28, 2024 under IB No. 2024-08-019;

WHEREAS, in response thereto, Benyol Construction & Supply was able to purchase bidding documents on August 13, 2024 and submit its respective bid before the set deadline on August 28, 2024;


