WHEREAS, the Municipality of Socorro through its Bids and Awards Committee, advertised and posted the Invitation to Bid for the Supply and Delivery Supplies, Materials and Equipment for Local Disaster Risk Reduction Management in the PhilGEPS website, LGU website and at the conspicuous places in the premise of the Municipality of Socorro on August 22, 2024 to September 10, 2024;


