RESOLUTION NO. 2024-10-409

A RESOLUTION RECOMMENDING THE USE OF REPEAT ORDER FOR THE PURCHASE OF THREE HUNDRED BAGS OF 25 KLS (300 bags of 25kls) ADDITIONAL REGULAR MILLED RICE FOR FARMERS FROM HOG-RAISING COMMUNITY UNDER LOCAL DISASTER RISK REDUCTION MANAGEMENT RECOVERY AND REHABILITATION PROGRAM

WHEREAS, presented before this Body is the need to purchase rice for the use of the Municipality of Socorro, to be distributed to the farmers from hog-raising community affected by ASF outbreak in the amount of Four Hundred Eleven Thousand Pesos (P 411,000.00);

WHEREAS, the Municipality of Socorro had previously procured regular milled rice through competitive bidding and distributed the said rice to qualified beneficiaries;

WHEREAS, pursuant to Section 48 of Rule XVI of the updated 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184, the Procuring Entity may resort to Alternative Methods of Procurement subject to prior approval of the Head of the Procuring Entity (HOPE) and whenever justified by the conditions provided in the aforementioned law;

WHEREAS, Section 51 of the same IRR states that Repeat Order, as one of the alternative modes of procurement, is a "method of procurement of goods from the previous winning bidder, whenever there is a need to replenish goods procured under a contract previously awarded through Competitive Bidding..." provided, that the terms and conditions for the use of the alternative methods of procurement found in Section 54 shall be followed, if applicable;

WHEREAS, the Municipality of Socorro had previously awarded the Contract for the Supply and Delivery of Regular Milled Rice in the amount of Two Million Five Hundred Eighty Six Thousand Five Hundred Sixty Pesos (P 2,586,560.00) on August 28, 2024; to which the procuring entity had already received the complete delivery on September 6, 2024;

WHEREAS, the Bids and Awards Committee has evaluated the request and found the Repeat Order to be justified and compliant with the provisions under Section 51 of the 2016 Revised Implementing Rules and Regulations of RA 9184 due to the following reasons:

- 1. That the unit of the items to be procured under Repeat Order is the same as in the original contract; and that price is still the most advantageous to the LGU;
- 2. That Repeat Order will not result to the splitting of contract, requisition of purchase order as provided for in Section 54.1 of the IRR;
- 3. That repeat order shall be availed within the period of six (6) months from the date of Notice to Proceed arising from the original contract;
- 4. That repeat order shall not exceed twenty five (25%) of the quantity of the item in the original contract.

WHEREFORE, on motion duly seconded, be it -

RESOLVED AS IT IS HEREBY RESOLVE to recommend the use of REPEAT ORDER as an alternative mode of procurement for the purchase of rice for farmers from hog-raising community affected by ASF and likewise found to be qualified beneficiaries of rice subsidy under LDRRM Recovery and Rehabilitation Program pursuant to Section 51 of the Revised 2016 IRR;

RESOLVED FURTHER that copy of this resolution be forwarded to the Office of the Mayor for information and appropriate action;

RESOLVED FINALLY that other concerned offices be furnished with a copy of this resolution for their information and reference.
