

RESOLUTION NO. 2024-10-412

RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT- SMALL VALUE PROCUREMENT AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE PURCHASE OF MATERIALS AND SUPPLIES TO BE USED IN THE CONDUCT OF HANDICRAFTS TRAINING (BEADS CRAFTING (BASIC) / BONSAI MONEY TREE AND STOCKING FLOWER MAKING) AS ALTERNATIVE LEARNING SCHOOL/ALS FOR THE OUT OF SCHOOL YOUTH (OSY) AND ADULT LEARNER'S IN THE MUNICIPALITY OF SOCORRO

WHEREAS, per Purchase Request No. 2024-10-398 dated October 2, 2024, the Municipality of Socorro has to purchase materials and supplies to be used in the conduct of Handicrafts training (Beads Crafting (BASIC)/Bonsai Money Tree and Stocking Flower Making) as Alternative Learning School/ALS for the Out of School Youth (OSY) and Adult Learner's in the Municipality of Socorro with an Approved Budget for the Contract of Fifty Seven Thousand Three Hundred Sixty Seven Pesos (Php.57,367.00);

WHEREAS, as a general rule, all procurement shall be done thru competitive public bidding except whenever justified by the conditions in order to promote economy and efficiency, may resort to any of the alternative mode of procurement;

WHEREAS, the above-mentioned procurement is recommended for Negotiated Procurement under Small Value Procurement considering that such procurement does not exceed the threshold of Two Hundred Thousand (P200,000.00) as prescribed in Annex H of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, under Section 53.9 of RA 9184, Small Value Procurement is one of cases that calls for the use of Negotiated Procurement;

NOW THEREFORE, we the members of the Bids and Awards Committee do hereby **RESOLVED** as it is hereby **HEREBY RESOLVED** -

- 1) To recommend that the purchase of materials and supplies to be used in the conduct of Handicrafts training (Beads Crafting (BASIC)/Bonsai Money Tree and Stocking Flower Making) as Alternative Learning School/ALS for the Out of School Youth (OSY) and Adult Learner's in the Municipality of Socorro with an Approved Budget for the Contract of Fifty Seven Thousand Three Hundred Sixty Seven Pesos (Php.57,367.00) be procured through alternative mode of procurement – Negotiated Procurement under Small Value Procurement;
- 2) To recommend for approval of the Municipal Mayor the foregoing findings.
