WHEREAS, the Municipality of Socorro through its Bids and Awards Committee, advertised and posted the Invitation to Bid for the Supply and Delivery of Construction Materials and Supplies for the Repair and Maintenance of School Buildings and Facilities in the PhilGEPS website, LGU website and at the conspicuous places in the premise of the Municipality of Socorro on October 1-22, 2024;
