**RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT- SMALL VALUE PROCUREMENT AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE PURCHASE OF PORK AND DRESSED CHICKEN TO BE USED IN THE PREPARATION OF MEALS AND SNACKS FOR THE OFFICIALS, TRAINERS, COACHES, CHAPERONS, MESS OFFICIALS AND ATHLETES DURING THE CONDUCT OF UNIT III SPORTS MEET 2024 (ELEMENTARY/SECONDARY LEVEL) TO BE HELD ON NOVEMBER 8-10, 2024**

WHEREAS, per Purchase Request No. 2024-10-435 dated October 30, 2024, the Municipality of Socorro has to purchase pork and dressed chicken to be used in the preparation of meals and snacks for the officials, trainers, coaches, chaperons, mess officials and athletes during the conduct of Unit III Sports Meet 2024 (Elementary/Secondary Level) to be held on November 8-10, 2024 with an Approved Budget for the Contract of One Hundred Twelve Thousand Four Hundred Seventy Five Pesos (Php.112,475.00);

WHEREAS, as a general rule, all procurement shall be done thru competitive public bidding except whenever justified by the conditions in order to promote economy and efficiency, may resort to any of the alternative mode of procurement;

WHEREAS, the above-mentioned procurement is recommended for Negotiated Procurement under Small Value Procurement considering that such procurement does not exceed the threshold of Two Hundred Thousand (P200,000.00) as prescribed in Annex H of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, under Section 53.9 of RA 9184, Small Value Procurement is one of cases that calls for the use of Negotiated Procurement;

NOW THEREFORE, we the members of the Bids and Awards Committee do hereby **RESOLVED** as it is hereby **HEREBY RESOLVED** -

- 1) To recommend that the purchase of pork and dressed chicken to be used in the preparation of meals and snacks for the officials, trainers, coaches, chaperons, mess officials and athletes during the conduct of Unit III Sports Meet 2024 (Elementary/Secondary Level) to be held on November 8-10, 2024 with an Approved Budget for the Contract of One Hundred Twelve Thousand Four Hundred Seventy Five Pesos (Php.112,475.00) be procured through alternative mode of procurement – Negotiated Procurement under Small Value Procurement;
- 2) To recommend for approval of the Municipal Mayor the foregoing findings.
