A RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT AS AN ALTERNATIVE METHOD OF PROCUREMENT IN THE SUPPLY AND DELIVERY OF OUTFIT AND ACCESSORIES FOR THE USE OF LGU'S OFFICIAL CANDIDATE TO THE SEARCH FOR MISS ORIENTAL MINDORO 2024 IN PARTICIPATION TO THE CELEBRATION OF 74TH FOUNDING ANNIVERSARY OF THE PROVINCE OF ORIENTAL MINDORO

WHEREAS, the LGU will send its official representative to the Miss Oriental Mindoro Beauty Pageant 2024 as one of its gestures of participation to various culminating activities in the celebration of the 74th Founding Anniversary of the Province of Oriental Mindoro;

WHEREAS, there is a need to procure the outfit and accessories to be used by the LGU's contestant in all activities and segments of the pageant to ensure the representation and preparedness;

WHEREAS, the probable costs of such particular materials and supplies amounted to Seventy Thousand Pesos (Php.70,000.00) as presented in approved Purchase Request No. 2024-10-411 dated October 14, 2024;

WHEREAS, per Section 53.9 of the 2016 Revised Implementing Rules and Regulations of RA 9184 clearly defines that Small Value Procurement is the procurement of goods, Infrastructure Projects and consulting Services that does not exceed the threshold prescribed in Annex of the said IRR;

WHEREAS, the intended procurement does not fall under Shopping of Section 52 of the aforementioned IRR;

WHEREAS, Small Value Procurement is one of the cases wherein which the Negotiated Procurement could be used as an alternative method of procurement;
