RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING ISSUANCE OF NOTICE OF AWARD

WHEREAS, the Municipality of Socorro through its Bids and Awards Committee, advertised and posted the Invitation to Bid for the Rehabilitation/Improvement of Bugtong na Tuog Water System in the PhilGEPS website, LGU website and at the conspicuous places in the premise of the Municipality of Socorro on November 7, 2024 to November 19, 2024 under IB No. 2024-11-033;

WHEREAS, in response thereto, JSLBuilders and Construction Supply was able to purchase bidding documents on November 14, 2024 and submit its respective bid before the set deadline on November 19, 2024;

WHEREAS, during the preliminary evaluation of bids, the technical and financial proposal of JSLBuilders and Construction Supply were both found to be substantially complying;

WHEREAS, upon post-qualification or careful examination, validation and verification of all eligibility, technical and financial requirements submitted by the bidder with the Single Calculated Bid, the bid of JSLBuilders and Construction Supply was found to be responsive;


NOW THEREFORE, we, the members of the Bids and Awards Committee do hereby RESOLVE as its is hereby RESOLVED to declare the bid of JSLBuilders and Construction Supply with a calculated financial proposal of Nine Hundred Ninety-Seven Thousand Five Hundred Thirteen Pesos and Forty Six Centavos (P 997,513.46) as the Single Calculated and Responsive Bid;


