**RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT - SMALL VALUE PROCUREMENT AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE PURCHASE OF SPARE PARTS AND REPAIR SERVICES FOR THE REPAIR AND MAINTENANCE OF DUMP TRUCK # 7 (ISUZU FWD – 6HH1)**

**WHEREAS**, per Purchase Request No.2025-02-019 dated February 6,2025 the Municipality of Socorro has to purchase of spare parts and repair services for the repair and maintenance of dump truck # 7 (Isuzu Fwd-6HH1) for the Approved Budget for the Contract of One Hundred Ninety Nine Thousand Two Hundred Thirty Eight Pesos (Php 199,238.00).

**WHEREAS**, under Republic Act No. 9184 (RA 9184), otherwise known as Government Procurement Reform Act“ (GPRA), and its Revised Implementing Rules and Regulations (RIRR), all procurement shall be undertaken through competitive public bidding except only under highly exceptional cases where the procuring entity may resort to alternative methods of procurement; and the same shall be subject to the prior approval of the Head of the Procuring Entity;

**WHEREAS**, the above mentioned procurement is recommended for Negotiated Procurement under Small Value Procurement considering that such procurement does not exceed the threshold of Two Hundred Thousand Pesos (Php. 200,000.00) as prescribed in Annex H of 2016 Revised Implementing Rules and Regulations of RA 9184;

**WHEREAS**, under Section 53.9 2016 Revised IRR of RA 9184, Small Value Procurement is one of cases that calls for the use of Negotiated Procurement;

**NOW THEREFORE**, we, the members of the Bids and Awards Committee do hereby **RESOLVED** as it is **HEREBY RESOLVED**

1) To recommend that spare parts and repair services for the repair and maintenance of dump truck # 7 (Isuzu Fwd -6HH1) with an Approved Budget for the Contract of One Hundred Ninety Nine Thousand Two Hundred Thirty Eight Pesos (Php. 199,238.00) be procured through alternative mode of procurement- Negotiated Procurement under Small Value Procurement;
