BAC RESOLUTION NO. 2025 - 037

RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT – LEASE OF REAL PROPERTY AND VENUE AS AN ALTERNATIVE MODE OF PROCUREMENT OF GOODS AND SERVICES FOR THE CONDUCT OF LIVE-IN WORKSHOP AMONG MEMBERS OF THE EXECUTIVE COMMITTEE AND TECHNICAL WORKING GROUP (TWG) OF THE GAD FOCAL POINT SYSTEM OF THE MUNICIPALITY OF SOCORRO

WHEREAS, the Municipality of Socorro intends to conduct a Gender and Development (GAD) Planning and Budgeting Workshop, requiring the lease of suitable venue, including accommodation, meals and function rooms, and necessary amenities to ensure a conducive learning environment;

WHEREAS, as requested and justified by the GAD Executive Committee, the herein mentioned activity is preferred to be conducted in Manila;

WHEREAS, under Section 53.10 of the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184, negotiated procurement is allowed for the lease of real property when it is more advantageous to the government and is highly specific to the needs of the procuring entity;

WHEREAS, the use of Negotiated Procurement – Lease of Real Property/Venue is deemed the most appropriate and advantageous method for securing the venue, due to the following reasons:

- a. Limited availability of suitable government owned venues
 - The workshop requires a venue with complete amenities, including function room, accommodation, catering services and the audio-visual facilities. Government-owned facilities within the area are either unavailable, insufficient or lack the necessary amenities, necessitating lease of private establishment.
- b. Cost efficiency and logistical considerations
 - Conducting the activity in a single venue that offers both accommodation and function room will be more cost-effective than booking separate facilities.
- c. Ensuring the privacy and focus of the activity
 - A dedicated venue will ensure that participants can focus on the discussions and activities without external interruptions, promoting a more productive and efficient workshop.

NOW THEREFORE, on motion duly seconded, the Bids and Awards Committee (BAC) RESOLVES, as it is further RESOLVED, to recommend the use of Negotiated Procurement – Lease of Real Property/Venue for the procurement of venue for the conduct of GAD planning and Budgeting Workshop in Manila;

RESOLVED FURTHER, that the BAC shall undertake the necessary procedures in adherence to the principles of transparency, efficiency and cost-effectiveness as required by RA 9184 and its Implementing Rules and Regulations.
