RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT- SMALL VALUE PROCUREMENT AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE HIRING OF TWO (2) UNITS COASTER VAN FOR THE TRANSPORTATION OF PARTICIPANTS OF GENDER AND DEVELOPMENT PLANNING AND BUDGETING WORKSHOP AMONG THE MEMBERS OF THE EXECUTIVE COMMITTEE AND TECHNICAL WORKING GROUP OF THE GAD FOCAL POINT SYSTEM OF THE MUNICIPALITY OF SOCORRO

WHEREAS, per Purchase Request No. 2025-03-046 dated March 3, 2025, the Municipality of Socorro has to hire two (2) units coaster van for the transportation of participants, from Socorro to Binondo Manila and vice versa, in the Gender and Development Planning and Budgeting Workshop among the members of the Executive Committee and Technical Working Group of the GAD Focal Point System with an Approved Budget for the Contract of One Hundred Forty Eight Thousand Two Hundred Pesos (Php. 148,200.00) ;

WHEREAS, under Republic Act No. 9184 (RA 9184), otherwise known as "Government Procurement Reform Act" (GPRA), and its Revised Implementing Rules and Regulations (RIRR), all procurement shall be undertaken through competitive public bidding except only under highly exceptional cases where the procuring entity may resort to alternative methods of procurement; and the same shall be subject to the prior approval of the Head of the Procuring Entity.

WHEREAS, the abovementioned procurement is recommended for Negotiated Procurement under Small Value Procurement considering that such procurement does not exceed the threshold of Two Hundred Thousand (P200,000.00) as prescribed in Annex H of 2016 Revised Implementing Rules and Regulations of RA 9184;


WHEREAS, under Section 53.9 of RA 9184, Small Value Procurement is one of cases that calls for the use of Negotiated Procurement;

- 1) To recommend that the hiring of two (2) units coaster van for the transportation of participants, from Socorro to Binondo Manila and vice versa, in the Gender and Development Planning and Budgeting Workshop among the members of the Executive Committee and Technical Working Group of the GAD Focal Point System with an Approved Budget for the Contract of One Hundred Forty Eight Thousand Two Hundred Pesos (Php. 148,200.00) be procured through alternative mode of procurement – Negotiated Procurement under Small Value Procurement;
