- WHEREAS, the Municipality of Socorro through its Bids and Awards Committee, advertised and posted the Invitation to Bid for the Supply and Delivery of Drugs and Medicines in the PhilGEPS website/LGU website and at the conspicuous places in the premise of the Municipality of Socorro on February 14, 2025 to March 10, 2025;
- WHEREAS, in response thereto, ORMIN Pharmaceutical Distribution and RBJM Pharmaceutical Trading purchased bidding documents on February 24, 2025 and March 05, 2025, respectively ORMIN Pharmaceutical Distribution submitted its bid on December 17, 2024 while RBJM Pharmaceutical Trading failure to submit its bid.;
