

RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING ISSUANCE OF NOTICE OF AWARD

WHEREAS, the Municipality of Socorro through its Bids and Awards Committee, advertised and posted the Invitation to Bid for the Supply and Delivery of Drugs and Medicines in the PhilGEPS website/LGU website and at the conspicuous places in the premise of the Municipality of Socorro on February 14, 2025 to March 10, 2025;

WHEREAS, in response thereto, ORMIN Pharmaceutical Distribution and RBJM Pharmaceutical Trading purchased bidding documents on February 24, 2025 and March 05, 2025, respectively ORMIN Pharmaceutical Distribution submitted its bid on December 17, 2024 while RBJM Pharmaceutical Trading failure to submit its bid.;

WHEREAS, during the preliminary evaluation of bids, the technical and financial component of ORMIN Pharmaceutical Distribution were both found to be substantially complying;

WHEREAS, upon post-qualification or careful examination, validation and verification of all eligibility, technical and financial requirements submitted by the bidder with the Single Calculated Bid, the bid of ORMIN Pharmaceutical Distribution was found to be responsive;


NOW THEREFORE, we, the members of the Bids and Awards Committee do hereby RESOLVE as it is hereby RESOLVED to declare the bid of ORMIN Pharmaceutical Distribution with a calculated financial bid of Two Million Three Hundred Thirty One Thousand Two Hundred Nineteen Pesos (2,331, 219.00) as the Single Calculated and Responsive Bid;
