RESOLUTION RECOMMENDING THE USE OF SHOPPING AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE SUPPLY AND DELIVERY OF SEMI-EXPENDABLE MACHINERY AND EQUIPMENT FOR THE OFFICIAL USE OF BUREAU OF FIRE PROTECTION PERSONNEL

WHEREAS, per Purchase Request No. 2025-04-087 dated April 21, 2025, the Municipality of Socorro has to purchase Semi-Expendable Machinery and Equipment for the official use of Bureau of Fire Protection Personnel with an Approved Budget for the Contract of One Hundred Twenty Two Thousand Eight Hundred Pesos (Php. 122,800.00);

WHEREAS, under Republic Act No. 9184 (RA 9184), otherwise known as "Government Procurement Reform Act" (GPRA), and its Revised Implementing Rules and Regulations (RIRR), all procurement shall be undertaken through competitive public bidding except only under highly exceptional cases where the procuring entity may resort to alternative methods of procurement; and the same shall be subject to the prior approval of the Head of the Procuring Entity.

**WHEREAS**, under Section 52 of the 2016 Revised IRR of RA 9184, Shopping is a method of procurement of goods whereby the procuring entity simply requests for the submission of price quotations readily available off-the-shelf goods or ordinary/regular equipment to be procured directly from supplier of known qualifications;

WHEREAS, pursuant to the above-mentioned provision, shopping may be employed the for the procurement of ordinary or regular office supplies and equipment not available in the Procurement Service involving an amount not exceeding the threshold prescribed in Annex H of said IRR;

NOW THEREFORE, we the members of the Bids and Awards Committee do hereby RESOLVED as it is Hereby RESOLVED
